FACTS ON THE FOURTEENTH CIRCUIT

- One of the largest geographic circuits in the state of Florida.
- Circuit stretches from the Emerald Coast of the Gulf of Mexico to the Alabama and Georgia state lines.
- 14th Circuit has county seats in the Central time zone as well as the Eastern time zone.

As the calendar turns to a new year, we here in the Fourteenth Judicial Circuit find ourselves reflecting back over the previous twelve months remembering all that transpired in the six counties of Bay, Calhoun, Gulf, Holmes, Jackson, and Washington.

In January our circuit gained two new judges. Judge Elijah Smiley was elected to a newly created

circuit judgeship appropriated by the Florida Legislature. No stranger to the bench, Judge Smiley previously served 11 years as a county judge in Bay County.

Judge Shane Vann was elected to fill the Bay County judgeship vacated when Judge Smiley

advanced. A native of Panama City, Judge Vann previously

The beginning of 2007 also brought about a special

milestone to the Fourteenth Circuit. Jackson County Judge Woodrow W. Hatcher and his judicial assistant Betty Carol Spooner celebrated 30 years of

service to the citizens of Jackson County. The staff of the Jackson County Probation Office honored the two with a special program followed by a reception, all held in the County Courtroom of the Jackson County Courthouse.

Early 2007 also brought new changes to the way weekend and holiday first appearances are handled in the outer counties of Calhoun, Gulf, Holmes, Jackson and Washington. Through a cooperative agreement between all judges, both circuit and county, assigned to the outer counties a system was

developed that allowed one judge to conduct first appearance hearings via video teleconferencing for all 5 counties. This rotation system only requires the judges to be responsible for first appearance hearings once every nine weeks. Spearheading this program were Washington County Judge Colby Peel and **Court Operations Consultant** Robyn Gable, who created a comprehensive bench book that is a readily available resource for the judge conducting the hearings.



In July of 2007 Circuit Judge Hentz

McClellan took on the task of Chief Judge for the Fourteenth Judicial Circuit. Having been elected to the circuit bench in 2002, Chief Judge McClellan has presided over cases in all six counties in the circuit. The first resident judge from Calhoun County to be elected by his peers to serve as Chief Judge of the Circuit, he splits his time between Bay, Calhoun, and Gulf Counties.

During the 2007 year, the Fourteenth Circuit made great strides in the area of Human Resources/ Personnel.



As the year progressed, so did the circuit. In an effort to be more "green" the circuit adopted a paperless timesheet system. No longer do employees have to manually maintain their leave and attendance records, all is recorded through the Information System Services team at the Office of State Court Administrator. With relatively few glitches, the system has simplified the record keeping of employees.

This past year saw the circuit adopt a New Employee Orientation Program that encompassed presentations from Personnel, Purchasing, Court Operations, Technology, the Trial Court Administrator, and the Chief Judge. The standardized program was designed to give an overall view of inner workings of Court Administration and the Court System as a whole. In maintaining a positive atmosphere for employees to work, the Fourteenth Judicial Circuit hosted the first Courts System Diversity Training workshop at Gulf Coast Community College in Panama City, Florida. The training was attended by employees from around the circuit and was conducted by trainers from the Human Rights Commission based in Tallahassee, Florida.



Team Building training was also conducted throughout the circuit. Staff from the Employee Assistance Program (EAP) conducted three successful sessions with court personnel in Marianna and Panama City. EAP also provides confidential programs dealing with personal difficulties, and are free to all employees and their eligible dependents.

2007 saw many programs expand to better serve the needs of the citizens here in the Fourteenth Judicial Circuit. The biggest expansion was in the area

of Alternative Dispute Resolution, many times referred to as mediation. Bay County has been successfully operating a County Court Civil Mediation Program for a number of years, but 2007 saw the expansion of this program to other counties in the circuit. Holmes, Jackson, and Washington counties made mediation a part of the County Court Civil process. Trainings have been held in several of the counties of the 14th Circuit

for those wishing to be certified as a volunteer county court mediator.

In addition to County Court Mediation, Alternative Dispute Resolution Director, Carol Dunaway, and her staff have been very busy over this past year. Mediation has expanded to new areas of the Court, including Family Court Mediation throughout the circuit and Dependency Mediation in Calhoun, Holmes, Jackson, and Washington Counties. The process of mediating disputes in the court system has proven to be very successful and reduces the time it takes to reach resolution of the pending case. The process is non-adversarial, and in the majority of cases a full or partial resolution is reached.

Top Television Shows of the Year, Top News Stories of the Year, Top Songs of the Year, etc.... Well, we (the technology staff of the Fourteenth Circuit) decided to create our own Top 10 Technology Projects of 2007.

There are several more projects we would could have listed, but the editor forced us to limit our list to 10! So without further delay, here are our Top Ten.

10. Digital Court Recording Playback

Systems-



Equipment was installed in each courtroom that allows the digital recordings to be played back remotely.

9. Courtroom Technology-Many software and hardware changes were made throughout the year to improve equipment used in the courtrooms.

8. Upgrade of the Universal Power Surge (UPS) Systems throughout the Circuit - UPS systems were upgraded to provide backup power. These systems are designed for short

term power interruptions, power surges, and brown outs. We also installed Power Distribution Units (PDU) that provide the ability to remotely turn power on and/or off to specific pieces of equipment.

7. Circuit Wide Network

Equipment Monitoring System-A new server and software system allows us to monitor, update, backup, and troubleshoot all of our network equipment.



6. Polycom GMS– This software enables us to manage and update all of our video systems from one location. If an IP address changes, we only have to update one system rather than thirty five.

5. File Server– Our new file server provides the circuit with a reliable system to store and retrieve work files.

4. Court TV Trial Broadcast– Our Courtroom Technology was on

and equipment at an off-site location, provided audio/ visual feeds to the media. and provided technological support to the lawyers.

3. Exchange Server 2007– This new system provides many new features and benefits that will be released in 2008. All you IM fans will be pleased!

2. My Florida Network (MFN)- We completed migrating all of our networks to high speed networks. The higher bandwidth provides us with resources to provide you with more services.

1. Iron Port Spam Filter-This project was the most visible project to all you our users in 2007. Over the last
